### §115.32. Health

#### (A) Introduction.

- (1) In health education, students acquire the health information and skills necessary to become healthy adults and learn about behaviors in which they should and should not participate. To achieve that goal, students will understand the following: students should first seek guidance in the area of health from their parents; personal behaviors can increase or reduce health risks throughout the lifespan; health is influenced by a variety of factors; students can recognize and utilize health information and products; and personal/interpersonal skills are needed to promote individual, family, and community health.
- (2) In Health 1, students develop skills that will make them health-literate adults. Students gain a deeper understanding of the knowledge and behaviors they use to safeguard their health, particularly pertaining to health risks. Students are taught how to access accurate information that they can use to promote health for themselves and others. Students use problem-solving, research, goal-setting, and communication skills to protect their health and that of the community.

<b>(3) Health information. The student recognizes the importance and significance of the reproductive process as it relates to the health of future generations. The student is expected to:</b>		
(A)	explain fetal development from conception through pregnancy and birth;	3
(B)	explain the importance of the role of prenatal care and proper nutrition in promoting optimal health for both the baby and the mother such as breast feeding;	3
(C)	analyze the harmful effects of certain substances on the fetus such as alcohol, tobacco, other drugs, and environmental hazards such as lead; and	3
(D)	explain the significance of genetics and its role in fetal development.	3
<b>(4) Health information. The student investigates and evaluates the impact of media and technology on individual, family, community, and world health. The student is expected to:</b>

(C)	appraise the significance of body changes occurring during adolescence.	5
<b>(7)</b>	<b>Health behaviors. The student analyzes the relationship between unsafe behaviors and personal health and develops strategies to promote resiliency throughout the life span. The student is expected to:</b>	
(A)	analyze the harmful effects of alcohol, tobacco, drugs, and other substances such as physical, mental, social, and legal consequences;	4, 5, 7
(B)	explain the relationship between alcohol, tobacco, and other drugs and other substances used by adolescents and the role these substances play in unsafe situations such as Human Immunodeficiency Virus (HIV)/Sexually Transmitted Disease (STD), unplanned pregnancies, and motor vehicle accidents;	7
(C)	develop strategies for preventing use of tobacco, alcohol, and other addictive substances;	7
(D)	analyze the importance of alternatives to drug and substance use;	7
(E)	analyze and apply strategies for avoiding violence, gangs, weapons, and drugs;	7

(B)	examine the legal and ethical ramifications of unacceptable behaviors such as harassment, acquaintance rape, and sexual abuse; and	5

<b>(15) Personal/interpersonal skills. The student appraises communication skills that show consideration and respect for self, family, friends, and others. The student is expected to:</b>		
(A)	apply communication skills that demonstrate consideration and respect for self, family, and others;	5

(A)	identify decision-making skills that promote individual, family, and community health;	5
(B)	summarize the advantages of seeking advice and feedback regarding the use of decision-making and problem-solving skills;	5
(C)	classify forms of communication such as passive, aggressive, or assertive; and	5
(D)	associate risk-taking with consequences such as drinking and driving.	7
<b>(17) Personal/interpersonal skills. The student applies strategies for advocating and evaluating outcomes for health issues. The student is expected to:</b>		
(A)	research information about a personal health concern;	4
(B)	demonstrate knowledge about personal and family health concerns; and	4
(C)	develop strategies to evaluate information relating to a variety of critical health issues.	4
